

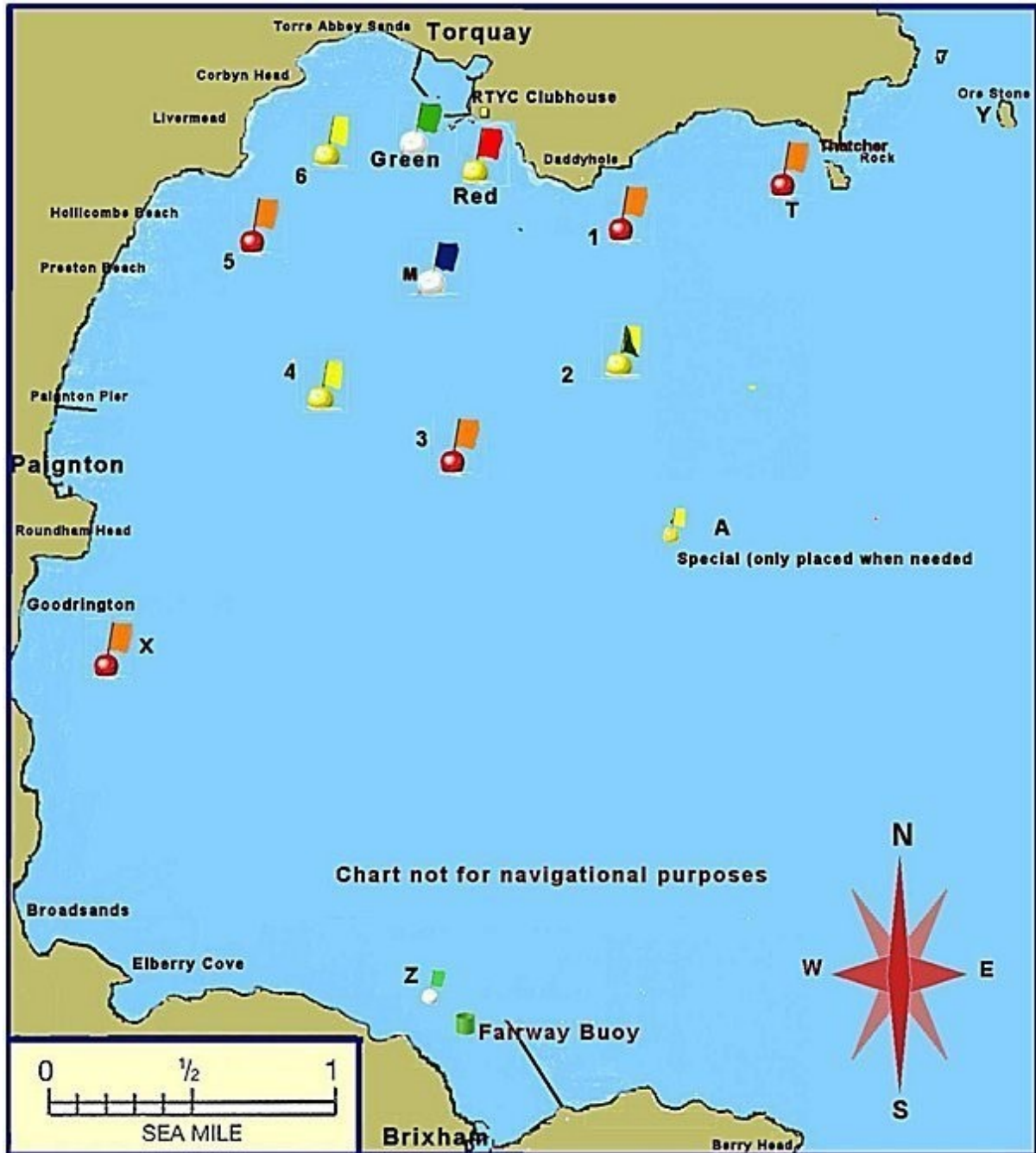
- I. The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- II. NOTICES TO COMPETITORS
  - A. Notices to competitors will be posted on the official notice board(s) located on the ground floor of the clubhouse.
- III. CHANGES TO SAILING INSTRUCTIONS
  - A. Any change to the sailing instructions will be posted before 0900 on the day it will take effect.
- IV. SIGNALS MADE ASHORE
  - A. Signals made ashore will be displayed on Haldon Pier.
  - B. When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 60 minutes' in the race signal AP.
- V. SCHEDULE OF RACES
  - A. 90 min (mean) pursuit race -earliest start 10:45
  - B. Up to 3 sprint races held asap afterwards
- VI. Priliminary Starting order and class flags for sprints shown in brackets
  - A. Double Handers (ICF 'E'),
  - B. Single Handers (ICF 'F'),
  - C. In the event a of a recall the order remains.
- VII. Racing Areas
  - A. Attachment A shows the location of the racing areas.
- VIII. The Courses
  - A. The course will be shown for the pursuit race on the back of the commitee boat.
  - B. The course for the sprints is shown in attachment B, it is expected that each race last no more than 20mins for the winning boat.
  - C. Courses will not be shortened, this changes RRS32.
- IX. Marks
  - A. Pursuit race will be raced using club racing marks as shown in attachment A
  - B. Sprint races will use yellow inflatable marks
  - C. Starting Pin will be white with an orange flag
  - D. Finishing Pin will be white with a blue flag.
- X. The Start
  - A. Pursuit Race - Starting times will be published online by 9:00 1/4/18
    1. 10:40 ICF E Up.
    2. 10:43 ICF E Down.
    3. 10:43:30 – "44" Displayed.
    4. 10:44:00 - "4" Removed
    5. 10:44:30 – 45 Displayed
    6. 10:45:00 – "5" removed etc etc until all Boats started.



- B. Sprint Races
    - 1. 3 min Class Flag up
    - 2. 2 min Blue Peter or replacement up.
    - 3. 1 min Blue Peter or replacement down.
    - 4. Start – Class Flag Down ( Note rolling starts are possible.)
  - C. The Startline will be between the orange flag on the committee boat and start pin.
- XI. The Finish.
- A. Pursuit Race
    - 1. The Finish line will be between the blue flag on the finishing boat and the next mark the leading boat is going to pass after mean boat has been racing 85mins. This will be announced by two short sound signals. The Race Committee reserve the right to finish remaining boats by rib driving backwards through the course.
  - B. Sprint Race
    - 1. Finish line will be between the blue flag on the committee boat and white buoy with Blue Flag.
- XII. Penalty System
- A. All Classes have RRS 41 changed so that the Two-Turns Penalty is replaced by a One-Turn Penalty.
  - B. Protest forms are available at the race office, located at the clubhouse.
  - C. Protests and requests for redress or reopening shall be delivered there within the appropriate time limit.
  - D. For each class, the protest time limit is 60 minutes after the last boat has finished the last race of the day or the race committee signals no more racing today, whichever is later.
  - E. Notices of protests by the race committee, technical committee or protest committee will be posted to inform boats under RRS 61.1(b).
  - F. Breaches of SIs 11.3, 18, 21, 23, 25, 26 and 27 will not be grounds for a protest by a boat. This changes RRS 60.1(a).
- XIII. Scoring
- A. Low Points scoring system in use.
  - B. The Pursuit race is scored twice in the series ( I.e it counts twice as much as a sprint race. It is also not discardable.)
  - C. All boats are in the same series, a points tie break solved by the finishing position of the pursuit race.
  - D. 1 discard after the second sprint is complete.
- XIV. Trash
- A. May be placed aboard support or official boats.
- XV. Prizes
- A. Will be given out for the individual series.
- XVI. Disclaimer of Liability
- A. Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
- XVII. Insurance
- A. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 3 million pounds per incident or the equivalent.
